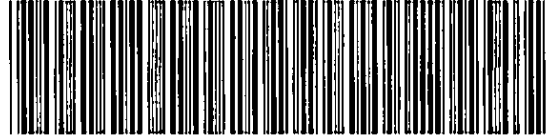



**ARTICLES OF ORGANIZATION  
OF  
INTERIORS BY ANAY, LLC**

**ARTICLE I**

**Name**

The name of the limited liability company ("Company") is INTERIORS BY ANAY, LLC.

**ARTICLE II**

**Address**

The mailing and street address of the Company's principal office is: 4831 Vasca Drive, Sarasota, Florida 34240.

**ARTICLE III**

**Purpose**

This limited liability company is organized to engage in the following purposes: to do interior design, and any and all lawful business for which companies may be organized under the laws of the State of Florida.

**ARTICLE IV**

**Duration**

The period of duration for the Company is perpetual, beginning on the date that these Articles of Organization are filed by the Florida Department of State.

**ARTICLE V**

**Registered Agent and Office**

## ARTICLE VI

### **Initial Members**

Any member shall have authority to bind the company.

## ARTICLE VII

### **Admission of Additional or New Members**

Members of the Company have the right to admit new members. Additional or new members may be admitted only on the unanimous written consent of the existing member or members, and the existing member or members shall determine the amount and nature of contributions to be made by the additional or new members at the time those new members are admitted.

## ARTICLE VIII

### **Management**

## ARTICLE IX






