

**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
EMAZE EXPORTS LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **EMAZE EXPORTS LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization of **EMAZE EXPORTS LLC** were filed on February 15, 2018 and assigned document number L18000040021.

SECOND: Article VI of the Company's Articles of Organization is hereby amended in its entirety to read as follows:

"ARTICLE V. MANAGEMENT
