The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be BAY2BAY VENTURES, LLC. ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 252 Bridgeport Lane, Elkton, Florida 32033.

ARTICLE III

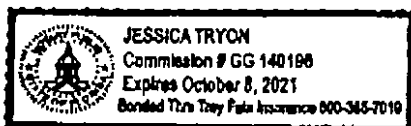


