**ARTICLES OF ORGANIZATION  
OF

1. Name. The name of this limited liability company is **CASA COOK MANAGEMENT, LLC**, a Florida limited liability company (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 3152 Little road, Suite 144, Trinity, FL 34655-1864.




