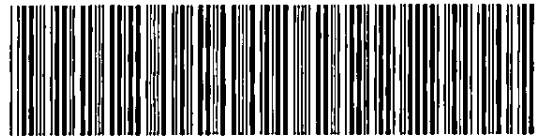



**Article I
Name and Document Number**
