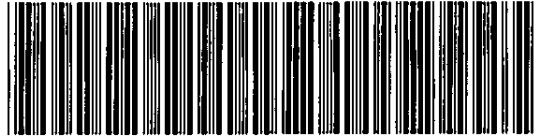

**THIRD:** Amendments adopted:


**ARTICLE I
