**ARTICLE 1 - NAME**

The name of the limited liability company shall be **SMARTSENSE USA LLC** ("Company").

**ARTICLE 2 - ADDRESS**

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

**ARTICLE 4 - DURATION**

**ARTICLE 5 - PURPOSES AND POWERS**




