**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 603, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I



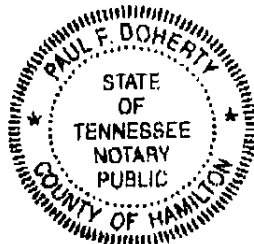
