The undersigned, Clare Therese Wilson, a natural person competent to contract and an authorized representative of Clare Taylor LLC, hereby presents these Articles of Organization as the Articles of Organization of Clare Taylor LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Clare Taylor LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
