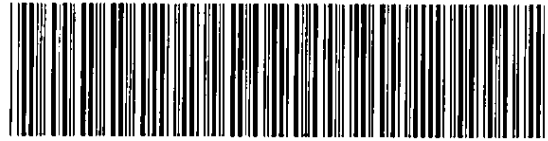

**ARTICLE I
NAME**

ORIGINALLY FILED ARTICLES**

**ARTICLE III
APPROVAL OF DISSOLUTION**

The Member of the Company held a special meeting on the 31st day of October, 2023 at which the sole Member of the Company was present. 
**ARTICLE IV


