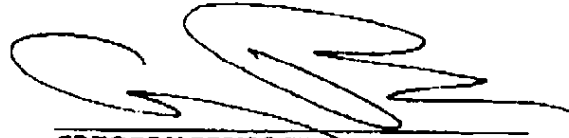
**ARTICLE IV
