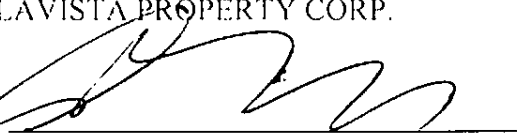
**ARTICLES OF CONVERSION

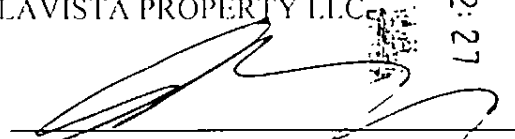

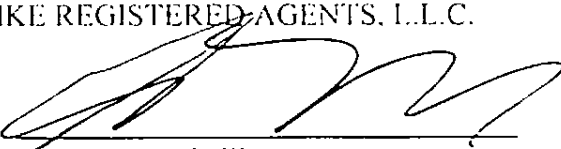

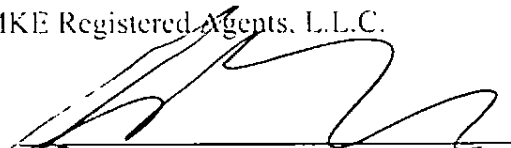
