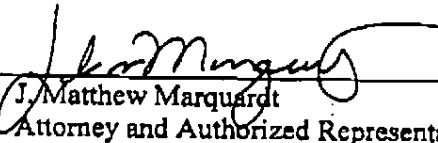
## ARTICLE VII

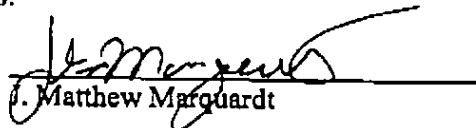
