AMENDED AND RESTATE
ARTICLES OF ORGANIZATION

WHEREAS, the date of filing of the articles of organization was March 12, 2018.

WHEREAS, pursuant to (i) the Florida Limited Liability Company Act, Chap. 605, Florida Statutes, and (ii) the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes (collectively the "Acts"), the following are adopted as the Articles of Organization of the professional limited liability company organized hereby:

ARTICLE I - NAME

The Company will be a manager-managed company managed in accordance with and subject to the requirements of the Acts and the Operating Agreement of the Company. The names and addresses of the


