ARTICLES OF ORGANIZATION
OF
OCALA NNN LLC

The undersigned, acting as the organizer Ocala NNN LLC, under the Revised Florida Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:


ARTICLE IV
