## MANAGEMENT

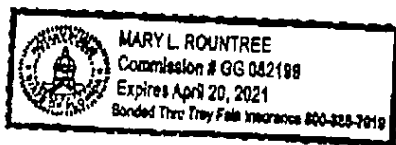
