The undersigned, ASHLEY R. CHANDLER, M.D., a natural person competent to contract and member of ASHLEY R. CHANDLER, M.D., PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 605, *Florida Statutes*.

ARTICLE I

The name of the professional limited liability company is:

ASHLEY R. CHANDLER, M.D., PLLC

This professional limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSES AND POWERS
