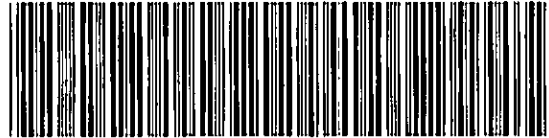

3. The date of this amendment's adoption is November 8, 2018.


4. The amendment of the article of organization was approved by all members on November 8, 2018. The number of votes cast for the amendment was sufficient for approval.


