TLC ISLAND DAWGS, LLC

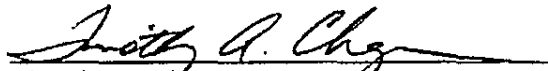
3. Date of Adoption. The amendment contained in these Articles of Amendment was adopted by resolution of the Members of the limited liability company on the 4th day of April, 2018.
