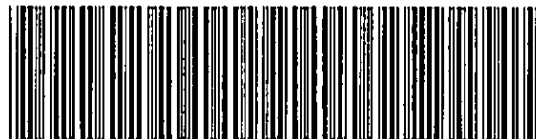

remove Mr. Manwar Khlaif Alshammari from the Article of Organization effective immediately.

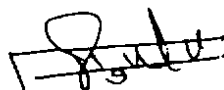

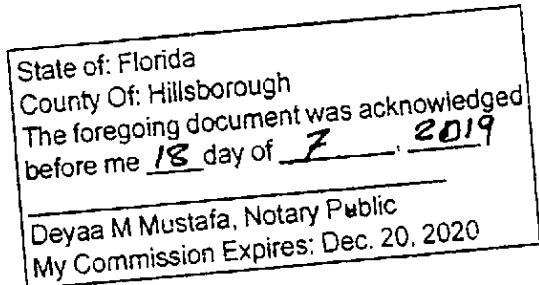
