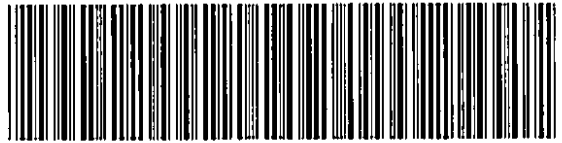


ARTICLE IV—ADMISSION OF ADDITIONAL MEMBERS
