The undersigned hereby submits these Articles of Organization (these "*Articles of Organization*") for purposes of forming PREMIER LANDSCAPES ORGANIZATION, LLC, a Florida limited liability company, (the "*Company*") under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*.

ARTICLE I – Name:

The name of the limited liability company formed pursuant to the filing of these Articles of Organization is PREMIER LANDSCAPES ORGANIZATION, LLC.

ARTICLE II – Address:

The mailing address and the street address of the principal office of the Company is 6441 South Chickasaw Trail, #411, Orlando, Florida 32829.

ARTICLE III – Initial Registered Agent and Office:

The initial registered agent for the Company shall be CT Corporation System, and the street address of the Company's registered agent is 1200 South Pine Island Road, Plantation, FL 33324.

ARTICLE IV – Adoption of Operating Agreement:

Additional persons shall not be admitted to the Company as members except in compliance with the procedures set forth in the Operating Agreement.

ARTICLE V- Duration:

The period of duration for the Company shall be perpetual, unless dissolved by its membership or in accordance with the terms of an operating agreement, if any.

ARTICLE VI – Management:

The Company shall be managed by a manager elected from time to time in accordance with the Operating Agreement (the "*Manager*").
