## AMENDED ARTICLES OF ORGANIZATION OF TURNKEY UTILITIES, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE I NAME
