

ARTICLES OF ORGANIZATION OF DANIELA MAR INVESTMENTS, LLC

The principal office and mailing address of the Company is as follows: 1180 N. Federal Highway #508, Fort Landerdale, Florida 33304.


ARTICLE UI REGISTERED AGENT AND OFFICE

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Sole Member of the Company in the manner set forth in the Operating Agreement of the Company.
