## ARTICLES OF ORGANIZATION OF LARRY S. FOLSOM CONSTRUCTION, LLC

The undersigned, for the purpose of forming a limited liability under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit.
