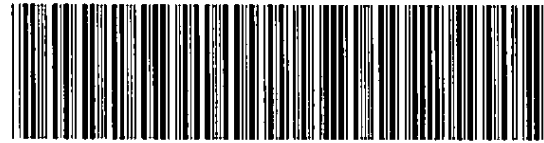

I, the undersigned subscribe to these Articles of organization, a natural person competent to contract, hereby form an organization under the laws of the State of Florida.

**Article I - Organization Name**

The name of this professional service organization is **MRD SOLUTIONS LLC.**

**Article II - The said principal office and mailing street address of this organization**

**Article III - Purpose**

The general nature of business to be engaged in by this organization will be to buy and sell real estate for its own benefit to purchase real estate for rehabilitation for sale to the general public at large. This company will also engage in construction of new homes and the remodeling of existing homes. In addition, one of its primary focuses will be on purchasing homes and rehabbing those homes in compliance with The Disabilities Act.

This company will engage in any other activities or business permitted under the laws of the United States of America to manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, manage, or otherwise dispose of, and to invest in, trade in, deal in

and with goods, wares merchandise, real and personal properties, and services, of every class, kind and description except it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad canal, telegraph, telephone, or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

To produce corporate assets of any other company property and engage in the same or other character of business.

### Article XI - Amendment

Notice in writing must be given by any shareholder to the President or a Vice-President of said organization not less than twenty-four (24) hours prior to the time set for the holding of a shareholders's meeting, for the election of directors that said shareholder intending to cumulate his vote at said election.

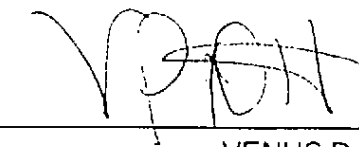
## **Article XIII - Section 1244**
