**ARTICLES OF MERGER
OF
THE VILLAGES INSURANCE PARTNERS, LLC
INTO
GUIDED INSURANCE SOLUTIONS, LLC**

Pursuant to the provisions of Section 605.1025 of the Florida Revised Limited Liability Company Act, THE VILLAGES INSURANCE PARTNERS, LLC, a Florida limited liability company (the "Merging Company"), and GUIDED INSURANCE SOLUTIONS, LLC, a Florida limited liability company (the "Surviving Company"), adopt the following Articles of Merger for the purpose of merging the Merging Company into the Surviving Company (the "Merger").
