The street address and the mailing address of the principal office of the Company are 11 E 29th Street, #10C, New York, New York 10016.

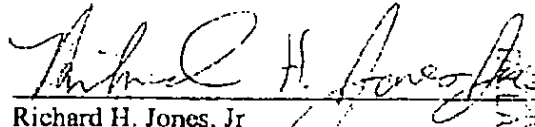
ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

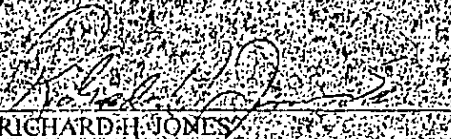
