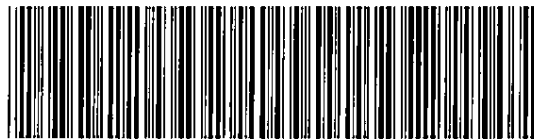

ARTICLE I - Name:

ARTICLE VII - Limited Liability Company Powers

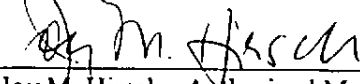

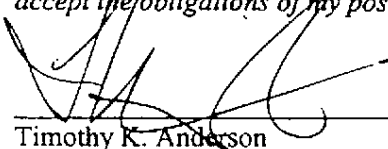
