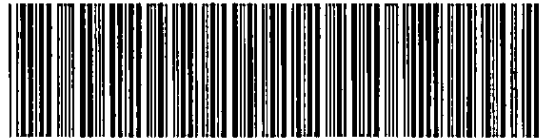

FIRST: The Articles of Organization of Turquoise Prop LLC were filed on March 21, 2018, and assigned Florida document number L18000077675.

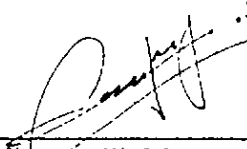
SECOND: The following amendment to the Articles of Organization was adopted by the sole Member of the limited liability company:
