ARTICLE VI - PURPOSE

The purpose of this Company is to carry on the same purpose of its sole member which is a Section 501(c)(3) tax exempt organization, whose exempt purpose is a religious church organization. The Company will be carrying out its sole Member's purpose through religious education and other lawful means which are permitted under Section 501(c)(3) of the Internal Revenue Code and the Regulation thereunder. The Company shall only exercise powers which are in furtherance of such exempt purposes.


ARTICLE VII – LIMITATION ON ACTIVITIES

The Company shall not carry on any activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

ARTICLE VIII - DISSOLUTION


Upon the dissolution and liquidation of the Company, the Company's member or appointed liquidating trustee, as applicable, shall, after paying or making provisions for the payment of all liabilities of the Company, make distributions of the assets of the Company to its sole member, so long as it is then a tax exempt organization within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code. In the event its sole member is not then a tax exempt organization at the time of the distributions, such assets shall be distributed to one or more tax exempt organizations, with a similar purpose, within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code or such assets shall be distributed to the federal government, or to a state or local government, for a public purpose.
