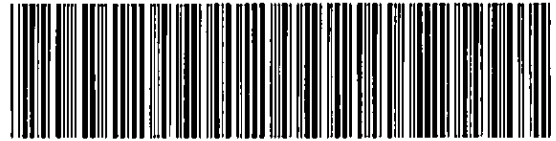

EFFECTIVE DATE AND PERIOD OF DURATION

These Articles of Organization shall have an effective date of March 30, 2018. The period of duration of the Company shall be perpetual.

**ARTICLE V
MANAGEMENT**

All powers of the Company shall be exercised by or under the authority of a manager or managers. The member may appoint one or more managers and grant them authority as specifically provided by statute or by the Operating Agreement. OPERATING AGREEMENT**

The member of the Company may adopt an operating agreement pertaining to the regulation, management, and other affairs of the Company (previously defined as the "Operating Agreement"), provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be repealed or altered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.

**ARTICLE VII
REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the Company's initial registered office in Florida is **511 W. Bay Street, Suite 320, Tampa, FL 33606** and the name of the initial registered agent is **ASGARD CORPORATE SERVICES LLC**. The Company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 605.0113, Florida Statutes.
