4. **Place of Principal Office.** The mailing and street address of the Company's principal office is 110 Walker Road, Crescent City, Florida 32112.

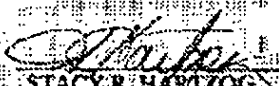

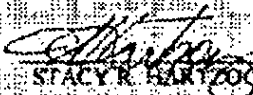
