**ARTICLES OF ORGANIZATION OF

The undersigned, STAR ROSTANKOVSKI, a natural person competent to contract and member of STARVISION OPTOMETRY, PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 605, *Florida Statutes*.

**ARTICLE I**
