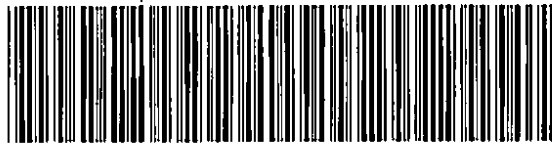

## ARTICLES OF ORGANIZATION
