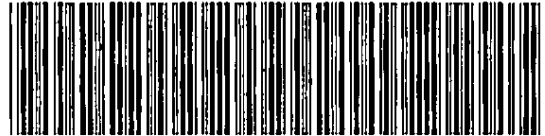

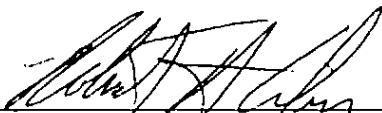

The Limited Liability Company shall have a perpetual existence.

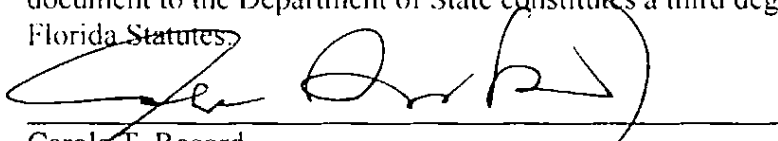
ARTICLE IX – MEMBERS LIMITED LIABILITY
