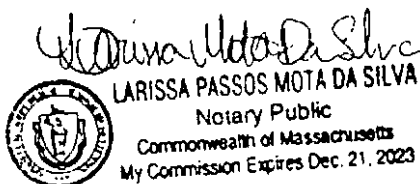

NARRATIVE

On 05/22/2018, Cambridge Police responded to a Suffolk Street residence for an Identity Fraud report. See narrative for further details.

On 05/22/2018, I Officer ALI (616) was assigned to uniform patrol route 4R for the First Half shift. At approximately 10:30 AM, I responded to 10 Suffolk Street #5, for an Identity Fraud report. Upon arrival, I spoke with the reporting party/victim, Kimberly YEASIR. YEASIR stated that she was just recently notified that someone had fraudulently opened (4) Wells Fargo accounts under her name. According to YEASIR, on April 6, two business checking accounts (ending in 3424 and 3416), were opened with YEASIR's name and registered to a company named Event Beauty Productions LLC. On April 20, a personal checking account ending in 8060 was opened. Finally, on April 30, a business credit account ending in 4207 was opened.

YEASIR has already spoken to the Identity Theft department at Wells Fargo to place a hold on the accounts. YEASIR was provided with the file number of this incident for her records.
