The undersigned, Louanne Spielman (a/k/a Louanne B. Spielman or Louanne Brandow Spielman), an individual Florida resident, acknowledges and states the following facts as true and correct:

1. On April 3, 2018, a Florida domestic LLC was formed under the name of "US Food Distribution Shipping LLC" (document number L18000084503) ("the Company")
2. The Registered Agent and Owner of the Company is shown to be "Louanne Spielman" with the Registered Agent address as 800 Village Square Crossing Unit 305, Palm Beach Gardens, FL 33410.
3. The Company has been fraudulently formed using the name (and identity) of the undersigned Louanne Spielman.
4. The undersigned, Louanne Spielman has nothing to do with this Company nor has she authorized in any manner the formation or the operation of the Company.
5. On April 9, 2018, the fraudulent activity allowed for the issuance of a Business Credit Card at Bank of America. Substantial expenditures and purchases were made using the fraudulently obtained Business Credit Card none of which were authorized or approved by the undersigned. Bank of America was notified by the undersigned on April 23, 2018 and Reports have been filed with the Bank of America Fraud Department.
6. On April 23, 2018, a Report of the fraudulent activity was filed with the Palm Beach Gardens Police Department.
7. On April 23, 2018, the undersigned notified Equifax, Experian and TransUnion Credit Bureaus of the "fraud activity" and has placed "Fraud Alerts" on her Credit Report at each of the Credit Bureaus.
8. On April 26, 2018, a Complaint was filed on behalf of the undersigned with the Federal Trade Commission.
9. The undersigned requests that the State of Florida, Division of Corporations immediately dissolve the Company.
10. The undersigned further requests that all further action be undertaken by all appropriate state and local governmental agencies, including law enforcement, such that no further fraudulent activity can be perpetrated on financial institutions, individuals or other companies.
