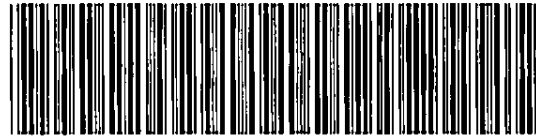

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
ZBS NEWS, LLC.
a Florida limited liability company**

ZBS News, LLC, a Florida limited liability company (the "Company"), pursuant to Section 605.0202, *Florida Statutes*, and other applicable provisions of the *Florida Revised Limited Liability Company Act*, Chapter 605, *Florida Statutes*, does hereby adopt and file the following Amended and Restated Articles of Organization:

1. The present name of the limited liability company is *ZBS News, LLC*.
2. The original Articles of Organization of the Company were dated April 4, 2018 and filed on April 4, 2018 and assigned document number L18000085178 (the "Original Articles").
3. The Amended and Restated Articles of Organization of the Company, which shall amend and restate the Original Articles in their entirety, are as follows:

ARTICLE I - NAME

The name of this Florida limited liability company shall be *ZBSNews LLC* (the "Company").


ARTICLE II - PRINCIPAL OFFICE STREET AND MAILING ADDRESS
