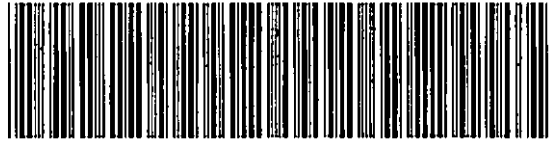

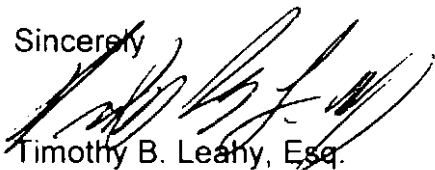

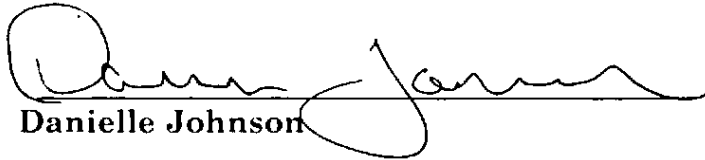
REGISTERED OFFICE AND AGENT

ADMISSION OF NEW MEMBERS

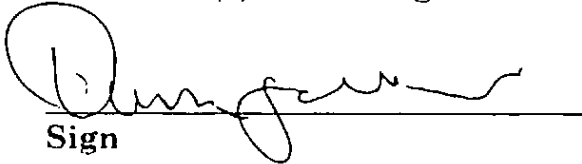

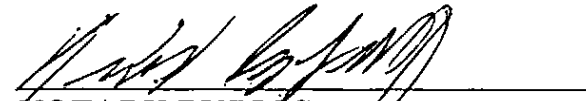
