- Name -

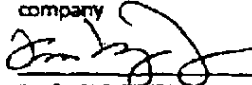

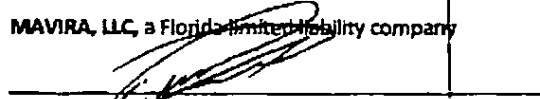
