4. Place of Principal Office. The mailing address and street address of the Company's principal office is 7248 North Dale Mabry Highway, Tampa, Florida 33614.

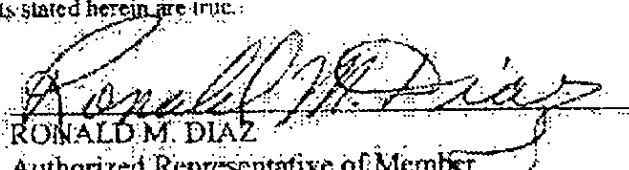
