This Statement of Correction corrects the Amended and Restated Articles of Organization filed with the Florida Department of State on April 25, 2018, which amended and restated the Articles of Organization filed on April 10, 2018 and assigned Document number L18000090769.

The Company's Amended and Restated Articles of Organization contain an incorrect statement; specifically, the name of one of the Company's initial managers is misspelled.

The Amended and Restated Articles of Organization identified one of the Company's initial managers as: Enrique A. Herilemann. However, the correct spelling of this individual's name is: Enrique A. Hirlemann. Accordingly, Article IV of the Company's Amended and Restated Articles of Organization is hereby corrected to read as follows:

"ARTICLE IV. MANAGEMENT

The Company is to be manager-managed. The names of the initial managers are: Jaime R. Topp, Gary Straus, Javier Colina, Enrique A. Hirlemann, and John P Sawinski."
