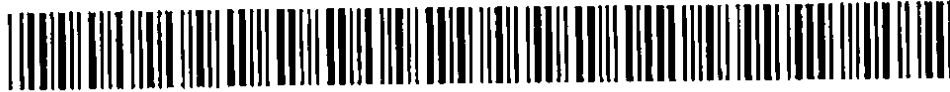

**STATEMENT OF AUTHORITY
