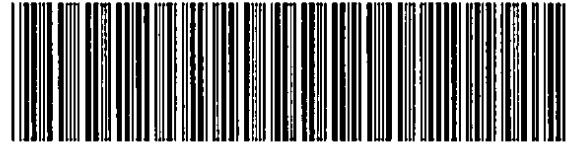

The Limited Liability Company is formed for the purpose of engaging in any lawful business.


**ARTICLE VII
