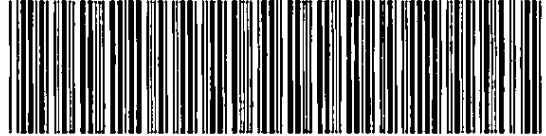



DURATION**


