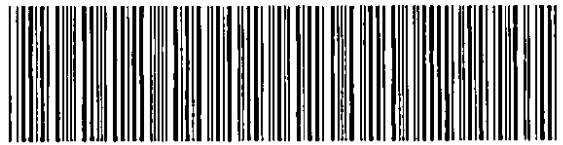

Amendment


Article I of the Articles of Organization is deleted in its entirety and replaced with the following:
