**ARTICLES OF ORGANIZATION  
OF  
16242 OUTLOOK SHORE ALLEY LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is 16242 OUTLOOK SHORE ALLEY LLC (the "Company").

**ARTICLE II. ADDRESS**

The principal and mailing address office of the Company is 16242 Outlook Shore Alley, Winter Garden, FL 34787.

**ARTICLE III. REGISTERED AGENT AND OFFICE**

The Company designates 11380 Prosperity Farms Road, #221E, Palm Beach Gardens, FL 33480 as the street address of the initial registered office of the Company and names Corporate Creations Network Inc. as the Company's initial registered agent at that address to accept service of process within this state.


