**ARTICLES OF ORGANIZATION
OF

ARTICLE I - Name:

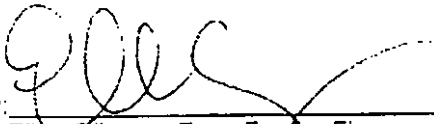

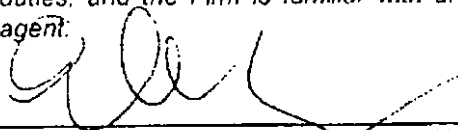
