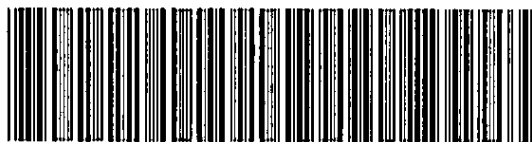


The Articles of Organization for this Limited Liability Company were filed on April 19, 2018 and assigned document number L18000099173.
